Definitions

compatibility

- the ability of machines, especially computers, or computer programs to work successfully with other machines or programs (Cambridge Dictionary)
- 소프트웨어 호환성, -互換性, software compatibility
 - 어떤 기종을 위해 개발된 프로그램을 그대로 다른 기종의 컴퓨터상에서 실행하는 것이 가능하고 동일한 결과를 얻을 수 있을 때, 그 두 기종 간에 발생하는 호환성. 그 기종 간의 하드웨어명령 집합이 동일하지 않아도 특정한 운영 체계(OS)에서 동작시킬 수 있거나, 특정한 언어 처리계를 이용함으로써 실현될 수 있는 경우에도 일반적으로 소프트웨어 호환성이 있다고 할 수 있다. (TTA 정보통신용어사전)

Definitions


License compatibility

is an issue that arises when licenses are applied to copyrighted works, particularly licenses of software packages (including software source code and binary representation).

Licenses can contain contradictory requirements, rendering it impossible to combine source code or content from such works in order to create new ones



 3.6. Distribution of Executable Versions. You may distribute Covered Code in Executable form only if ...

You may distribute the Executable version of Covered Code or ownership rights under a license of Your choice, which may contain terms different from this License, provided that You are in compliance with the terms of this License and that the license for the Executable version does not attempt to limit or alter the recipient's rights in the Source Code version from the rights set forth in this License. ...

• 3.5. Distribution of Executable Versions. You may distribute the Executable form of the Covered Software under the terms of this License or under the terms of a license of Your choice, which may contain terms different from this License, provided that You are in compliance with the terms of this License and that the license for the Executable form does not attempt to limit or alter the recipient's rights in the Source Code form from the rights set forth in this License. ...

- Copyleft and No further restrictions in GPL 2.0
 2.b) You must cause any work that you distribute or publish, that in whole or in part contains or is derived from the Program or any part thereof, to be licensed as a whole at no charge to all third parties under the terms of this License.
 - 6. ... You may not impose any further restrictions on the recipients' exercise of the rights granted herein.

Solutions: License Amendment

- GPL 3.0
 - 7. Additional Terms.

Notwithstanding any other provision of this License, for material you add to a covered work, you may (if authorized by the copyright holders of that material) supplement the terms of this License with terms:

- a) <u>Disclaiming warranty or limiting liability</u> <u>differently</u> from the terms of sections 15 and 16 of this License; or
- b) Requiring preservation of specified reasonable legal notices or author attributions in that material or in the Appropriate Legal Notices displayed by works containing it; or

- c) Prohibiting misrepresentation of the origin of that material, or requiring that modified versions of such material be marked in reasonable ways as different from the original version; or
- d) <u>Limiting the use for publicity purposes of names of licensors or authors</u> of the material; or
- e) <u>Declining to grant rights under trademark law</u> for use of some trade names, trademarks, or service marks; or

Solutions: License level

- LGPL -> GPL
 - LGPL 2.1
 - 3. You may opt to apply the terms of the ordinary GNU General Public License instead of this License to a given copy of the Library. To do this, you must alter all the notices that refer to this License, so that they refer to the ordinary GNU General Public License, version 2, instead of to this License. (If a newer version than version 2 of the ordinary GNU General Public License has appeared, then you can specify that version instead if you wish.) Do not make any other change in these notices.
 - Once this change is made in a given copy, it is irreversible for that copy, so the ordinary GNU General Public License applies to all subsequent copies and derivative works made from that copy.
 - This option is useful when you wish to copy part of the code of the Library into a program that is not a library.

- Mozilla Project
 - Around 2001 Time Warner, at the request of the Mozilla Foundation, relicensed all code in Mozilla that was under the Netscape Public License (including code by other contributors) to an MPL 1.1/GPL 2.0/LGPL 2.1 tri-license
- Vorbis library, VLC project, Wikipedia, linux kernel head files by google, FreeCAD, ...

- MPL 2.0
 - 3.3. Distribution of a Larger Work
 - You may create and distribute a Larger Work under terms of Your choice, provided that You also comply with the requirements of this License for the Covered Software. If the Larger Work is a combination of Covered Software with a work governed by one or more Secondary Licenses, and the Covered Software is not Incompatible With Secondary Licenses, this License permits You to additionally distribute such Covered Software under the terms of such Secondary License(s), so that the recipient of the Larger Work may, at their option, further distribute the Covered Software under the terms of either this License or such Secondary License(s).
 - 10.4. Distributing Source Code Form that is Incompatible With Secondary Licenses

- (i) the Original License or
- (ii) a license that permits the licensee to freely copy, modify and redistribute the Modified Version using the same licensing terms that apply to the copy that the licensee received, and requires that the Source form of the Modified Version, and of any works derived from it, be made freely available in that license fees are prohibited but Distributor Fees are allowed.
