## 나. 원문

BOSTON, Massachusetts, USA -- Monday, November 3, 2008 -- The Free Software Foundation (FSF) today announced the release of version 1.3 of the GNU Free Documentation License (FDL). This version of the license allows public wikis to relicense their FDL-covered materials under the Creative Commons Attribution-ShareAlike (CC-BY-SA) 3.0 license.

This new permission has been added at the request of the Wikimedia Foundation, which oversees the Wikipedia project. The same terms are available to any public wiki that uses materials available under the new license. The Wikimedia Foundation will now initiate a process of community discussion and voting to determine whether or not to use CC-BY-SA 3.0 as the license for Wikipedia.

"Wikis often import material from a wide variety of sources, many of which use the CC-BY-SA license," said Brett Smith, licensing compliance engineer at the FSF. "Wikipedia, however, uses the GNU FDL. The incompatibility between these two licenses has been an obstacle to moving material back and forth between these sites. The new provision of FDL version 1.3 will give Wikipedia and other wikis another chance to choose the licensing policies they prefer."

"We are grateful to the leadership of the Free Software Foundation for taking this important step," explained Sue Gardner, executive director of the Wikimedia Foundation. "In doing this, the FSF is giving the Wikimedia community an opportunity to make a licensing decision that honors our mutual commitment to free culture, and best supports the mission and goals





of Wikipedia and its sister projects."

Version 1.3 of the GNU FDL also adopts the license proxy and termination clauses that are part of the GNU General Public License version 3, released last year. The text of CC-BY-SA 3.0 is available at http://creativecommons.org/licenses/by-sa/3.0/.

## 다. 이슈내용

2008년 11월 3일 월요일, 미국, 메사추세츠 주, 보스턴

자유 소프트웨어 재단(FSF)은 오늘 GNU Free Documentation License 1.3 버전을 발표했다. 이 버전의 라이선스 내용은 공용 위키가 CC-BY-SA 3.0 라이선스 하에 그들의 FDL 재라이선스를 허용했다.

새로운 라이선스는 Wikimedia Foundation의 요구를 추가했다. Wikipedia 프로젝트를 가만히 바라보면, 같은 조건에 해당하는 모든 새 라이선스 하에 공개 위키를 사용할 수 있다. Wikimedia Foundation은 커뮤니티 토론을 시작할 것이고, Wikipedia의 라이선스인 CC-BY-SA 3.0 라이선스를 사용할 것인지 아닌지 투표하기로 결정했다.

"위키는 종종 소스의 다양한 변화로부터 CC-BY-SA 라이선스의 많은 사용을 가져온다."라고 FSF의 라이선스 컴플라이선스 엔지니어인 Brett Smith는 말했다. "Wikipedia 하지만, GNU FDL을 사용합니다. 그 비호환성이 두 라이선스를 사이에두고 사이트 간의 이동에 걸림돌이 되고 있다. FDL 1.3버전의 새로운 준비는 위키미디어와 다른 위키들에게 그들이 제공하는 라이선스 정책들을 선택할 수 있는 또다른 찬스를 제공한다."

"우리는 FSF의 중요한 단계에서 FSF의 리더쉽에 감사한다." 라고 위키미디어 재단의 이사인 Sue Gardner가 설명했다. "이렇게 하는 것은, FSF가 위키미디어 커뮤니티에게 라이선스 정의를 만드는 기회를 주는 것이다. 그리고 미션에 대한 최상의지원과 위키미디어의 목표이며, 자매결연 프로젝트들이다."

## 라. GFDL 1.2에서 변경된 사항

GFDL 1.2 버전은 2002년 11월에 발표되었으며, GFDL 1.2가 발표된지 정확히 6년 만에 1.3버전을 발표하였다.

이번에 새롭게 업데이트 되면서 기존 버전과 다른 점은 다음과 같다.

## 1. APPLICABILITY AND DEFINITIONS항의 내용추가

"The "publisher" means any person or entity that distributes copies of the Document to the public."

### 2. TERMINATION 항의 내용 변경 or 추가

"Massive Multiauthor Collaboration Site" (or "MMC Site") means any World Wide Web server that publishes copyrightable works and also provides prominent facilities for anybody to edit those works. A public wiki that anybody can edit is an example of such a server. A "Massive Multiauthor Collaboration" (or "MMC") contained in the site means any set of copyrightable works thus published on the MMC site.

"CC-BY-SA" means the Creative Commons Attribution-Share Alike 3.0 license published by Creative Commons Corporation, a not-for-profit corporation with a principal place of business in San Francisco, California, as well as future copyleft versions of that license published by that same organization.

"Incorporate" means to publish or republish a Document, in whole or in part, as part of another Document.

An MMC is "eligible for relicensing" if it is licensed under this License, and if all works that were first published under this License somewhere other than this MMC, and subsequently incorporated in whole or in part into the MMC, (1) had no cover texts or invariant sections, and (2) were thus incorporated prior to November 1, 2008.

## 3. 이슈사항이 공개SW에 미치는 영향

GNU Free Documentation License는 그간 FSF 및 기타 공개SW 커뮤니티에서 사용하는 문서 라이선스의 기본 틀이 되었다고 할 수 있다. 기본적으로 영리, 비영리에 관계없이 수정 작성을 허가하지만 GPL과 마찬가지로 수정된 문서도 GFDL을 따라야합니다. 이번 GFDL 1.3버전의 발표에서 특징적인 점은 기존의 CCL과의 입장차이를 좁혀 두가지 규약을 하나로 통합 한 내용으로 볼 수 있습니다. GFDL이 GPL과 마찬가지로 저작물의 자유로운 공유에 초점이 맞추어져 있다면, CCL은 저작권자 및 사용자에게 초점이 맞추어져 있다고 할 수 있다. 이번 라이선스 발표로 CCL의 내용이 GFDL 라이선스안에 포함되어 지고 내용이 수정되면서 향후 저작권에 관련된 여러가지 논의가 줄어들 수 있게 되었다.

금번 GFDL의 변경은 이전 WMF에서 위키피디아가 BY-SA의 CCL 조건과 호환되도록 GFDL을 수정해달라고 FSF에 요청한대 따른 결과라고 할 수 있다.

Everyone is permitted to copy and distribute verbatim copies of this license document, but changing it is not allowed.

#### 0. PREAMBLE

The purpose of this License is to make a manual, textbook, or other functional and useful document "free" in the sense of freedom: to assure everyone the effective freedom to copy and redistribute it, with or without modifying it, either commercially or noncommercially. Secondarily, this License preserves for the author and publisher a way to get credit for their work, while not being considered responsible for modifications made by others.

This License is a kind of "copyleft", which means that derivative works of the document must themselves be free in the same sense. It complements the GNU General Public License, which is a copyleft license designed for free software.

We have designed this License in order to use it for manuals for free software, because free software needs free documentation: a free program should come with manuals providing the same freedoms that the software does. But this License is not limited to software manuals; it can be used for any textual work, regardless of subject matter or whether it is published as a printed book. We recommend this License principally for works whose purpose is instruction or reference.

#### 1. APPLICABILITY AND DEFINITIONS

This License applies to any manual or other work, in any medium, that contains a notice placed by the copyright holder saying it can be distributed under the terms of this License. Such a notice grants a world-wide, royalty-free license, unlimited in duration, to use that work under the conditions stated herein. The "Document", below, refers to any such manual or work. Any member of the public is a licensee, and is addressed as "you". You accept the license if you





copy, modify or distribute the work in a way requiring permission under copyright law.

A "Modified Version" of the Document means any work containing the Document or a portion of it, either copied verbatim, or with modifications and/or translated into another language.
